By-Law No. 14-18
Special Services Plan No. 02-18
For

Collection and Transportation of Waste and Recyclable Materials in the Communities of Dominion City and Emerson and the Collection of Recyclables in the Communities of Arnaud and Ridgeville.

(Pursuant to Subsection 314 of the Municipal Act)

The Council of the Municipality of Emerson-Franklin has scheduled a public hearing in the Municipal Council Chambers at 115 Waddell Avenue E, in Dominion City, Mb on the 11th day of December, 2018 at 10:00 a.m. to present the following special service proposal.

The Communities of Dominion City and Emerson currently receive collection and transportation services for waste and recyclable materials and the communities of Arnaud and Ridgeville currently receive collection and transportation services for recyclable materials. The garbage collection service provides curbside pickup one time per week. The recycle collection service provides curbside pickup one time biweekly.

The Municipality levies a special service per parcel tax to recover the Collection and Transportation fees for both garbage and recyclables.

Special Service By-Law Nos. 01-14, 02-14 and 06-15 expire at the end of 2018 and council is proposing to continue to levy an annual per parcel rate to ensure sufficient funds are raised for the waste collection and transportation service over the next 5 year period. The plan proposes a \$3 increase in each of the years to cover the costs of the service for Garbage and Recycle Pick up in Dominion City and Emerson.

The estimated annual cost for this service is as follows:
